### Health and Human Rights

#### **Content Overview**

This course of study covers the general concepts and principles of human rights, their relationship to, and impact within the health sector.

The course will use case studies from numerous countries, with a focus on low and middle-income countries, and the experiences of those within the course, to examine the vital role of human rights within the health sector.

Participants will have the opportunity to practice incorporating human rights into policies, strategies, monitoring and evaluation.

#### **Learning Objectives**

To enable health professionals and managers to understand the concepts and principles of human rights within the health sector and to improve their personal skills in applying and evaluating these rights.

By the end of the course participants should be able to:

- Articulate the key principles that underpin human rights discussions within the health sector
- 2. Assess the implications for health within UN conventions, treaties and international declarations related to human rights.
- 3. Articulate and explain human rights principles in relation to the main topics within the health sector:
  - a. Equity and Equality: urban/rural bias, the poor, marginalized groups, gender, minorities, disabled, elderly
  - Access: harm reduction services, reproductive health services, HIV/AIDS services, access to health for refugees/IDPs in armed conflicts
  - c. Accountability: development of more responsive public health policies, monitoring progress, unintended impacts of laws

#### Learning Objectives cnt.

- 4. Elaborate the importance of applying a rights based approach to health
- 5. Discuss the implications on human rights resulting from national health laws or policies (for example, the human rights implication of China's 'one-child' policy or the USA's 'Obamacare' policy).
- 6. Articulate the key mechanisms at national, regional and international mechanisms designed to protect and promote human rights within the health sector.
- 7. Elaborate strategies to monitor the application of human rights principles in the health sector.

#### **Learning Methods**

The course is composed of individual teaching units, individual or group practical exercises.

#### **Assessment Procedures**

Course participants are expected to attend teaching sessions and participate regularly in discussions and group work.

Final assessment based on writing sample (policy brief or essay, not exceeding 950 words) to be submitted at the last day of the course.

#### **Duration / Accreditation**

2 weeks / 90 hours; Full time attendance required.3 ECTS (tropEd)

#### **Target Group / Prerequisites**

Public health professionals, project planners and managers, paramedical staff, social scientists, tropEd students, etc. The course is held in English.

Fluent English (Reading, Speaking and Writing) is required for the course.

#### **Course Fee**

General Admittance € 1.500,tropEd students € 750,-

(reduced fee currently)
